# **COSA NEWS** *president's report*

It is hard to believe but this is actually my last Marryalyan column as the COSA President. No, I am not going anywhere yet, but with the new schedule of the Marryalyan where our last issue is the Christmas issue, my contribution to the next edition will be as brand new retiree rather than "the one with whom the buck stops". It seems like it was only yesterday that I had been drafting my first Marryalyan column and now it is time to sit down to the last one. Such is life, you may say, and if we in oncology do not know about how fleeting time is, we have not learned much from our profession.

But this column is not meant to be about the reflections of an individual, even if she has a privilege to hold the Presidency, as COSA is not a one man show. I want to write about COSA as an organisation. This opening is more to remind us all that time is ticking, not just for me but for all of us. For the President, the time at the helm is just a blink. What matters is an enduring track record of the organisation and this year COSA is officially becoming middle aged and turning 40! That is a pretty impressive achievement for an organisation built around professions, many of which did not exist 50 years ago. This year COSA is facing the significant challenge of ensuring that the members engage in the decision process regarding its organisational structure. We started the discussion about governance in 2010 and it is time to arrive at the resolution stage. The proposed changes described in more detail elsewhere in this issue (pages 3-5), are designed to allow COSA to grow and engage with the growing number of cancer organisations of similar interest, while maintaining a flexible structure that supports the growing and evolving interests of individual members. We want to build on the tradition of COSA but ensure that its operations are supported by the strong foundations of sound corporate governance that an organisation of this size requires in the modern age. Please familiarise yourself with the proposed changes, get involved in the online and face to face discussion, come to breakfasts that COSA will be hosting in Melbourne and Brisbane (we have had one in Sydney), speak to your colleagues, but most importantly do have a say in how you want COSA to grow. And have a say at the Annual General Meeting in November. You are part of COSA - your vote counts.

We have had an example that your vote matters just recently when you were involved in choosing the next President Elect. It is great to see two outstanding individuals stepping up to offer their vision for the organisation. We have received an outstanding response from members – as the voting is anonymous, I do not know the results of the ballot but I am delighted that so many of you had a say. I hope to see more of this type of engagement in the future and I congratulate both Jane Turner and Mei Krishnasamy for their outstanding vision and commitment to COSA.

Organisations like COSA are built on the strength, passion and commitment of individuals. Being part of COSA is not a job;

## **Executive Officer's Report**

Where do the days, weeks, months go?? It hardly seems like four months have passed since the last Marryalyan, but because so much has happened in between reports it may well have been longer.

It was great to meet some of you at the COSA Members' Breakfast held in Sydney on 25 May. This event provided an excellent forum for a vibrant and open discussion about what the proposed changes really mean for COSA members. We found that despite our best efforts in communicating change, it's not always easy to understand in written materials, and the face-toface discussion really helped both the COSA members present as well as the Council. So if you're in Melbourne on 31 August please come along to the COSA Members' Breakfast there, otherwise we hope to see you at the breakfast prior to the ASM on Monday 12 November in Brisbane.

To learn more about our activities as the peak society for health professionals working in cancer care, I recommend you read the COSA Groups reports on the following pages. I'd also like to highlight a few key items which do not appear elsewhere in this newsletter but are equally important to showcase.

- COSA's Cancer Australia funded Consumer Engagement in Clinical Cancer Research project has reached a huge milestone recently. Some of the e-learning modules have been approved by Cancer Australia and will be tested for user suitability and functionality throughout August.
- John Zalcberg and Mei Krishnasamy represented COSA at a private meeting with the McKeon review panel on 1 May 2012 to discuss our submission to the Strategic Review of Health and Medical Research in Australia, March 2012. Adequate funding for cancer research – particularly investigator initiated clinical trials run by the CCTGs - remains an ongoing challenge. Generally they are sympathetic to the issues presented by COSA and the CCTGs, but it remains unclear as to how additional funds may be sourced.
- Bogda Koczwara was invited to attend as a witness at the Senate hearing regarding the factors affecting the supply of health services and medical professionals in rural areas in Canberra on Friday 11 May 2012 following our joint submission with Cancer Council Australia.
- Jane Phillips represented COSA at the Senate hearing for the inquiry into Palliative Care in Australia on 2 July 2012.
- On 2 May I attended the Cancer Council NSW Research Awards where I was pleased to see Prof Anna Nowak, COSA member, awarded a cancer research grant for her work in brain cancer. Liz Hovey accepted the award on behalf of Anna - I guess travelling from Perth might have been a bit too much to ask of Anna!

## **Proposed changes to COSA Governance and Constitution**

At the November AGM, COSA members will be invited to vote on the proposed changes to the COSA Governance as summarised in the amended Constitution. The following outlines the background behind the change, the details of changes and how you can learn more. It is critical that members familiarise themselves with these changes so they can provide feedback before they are presented and cast an informed vote on the day.

#### Why change?

As COSA is becoming larger and its membership is more diverse, and as cancer care evolves, there is a need for our organisation to engage with multiple organisations and individuals who may wish to become part of COSA and at the same time maintain a strong, effective and flexible governance process that is compliant with modern governance expectations. At present the role of the governing body (the Board) and members' forum is discharged to the COSA Council. While the Council is most appropriate as a members forum and could grow to include new members' interests, growing the Council as a governing body is problematic as it is not possible for the Council to discharge its Board requirements within its current size.

The purpose of the proposed changes is to ensure that COSA creates an effective smaller board to govern the organisation, while preserving the role of the Council as an advisory forum that incorporates all the interests of COSA members and has the capacity to grow as new members come on board. The process of this change requires clarification of members' rights and responsibilities to ensure consistency and fairness and to ensure that the historical value of the COSA Council is not diminished by the proposed changes.

#### Proposed changes:

#### **COSA Governance**

- a. The Board of COSA shall consist of eight (8) to eleven (11) members: comprising the incumbent President and President Elect, and six (6) members elected by the COSA Council from within its current or previous membership; two (2) may be co-opted as required; and one (1) shall be nominated by Cancer Council Australia.
- b. COSA Council will provide advice to the Board and serve as the main forum of representation for COSA Members and Affiliated Organisations.
- c. Individual COSA Members will have an option of representation at the COSA Council via the Chair of the Group(s) they select. Affiliated Organisations will be entitled to a seat at the COSA Council. The COSA Council representative of the Affiliated Organisation must be a COSA member.
- d. At no stage will Affiliated Organisations hold more than 49% of the COSA Council seats.
- e. COSA Members will have the right to vote at the AGM. Affiliated Organisations will not have a vote at the AGM but their COSA Council representatives and their own organisation members who are COSA Members can exercise their individual member votes as they see fit.

#### **COSA Organisational structure**

- 1. COSA will provide 2 types of membership:
- Individual open to all individual health care professionals working or training in the cancer field. Holders of individual membership will be known as COSA Members.
- **Organisational** open to independent organisations of cancer professionals that share their objectives with those of COSA. Organisational members will be known as **Affiliated Organisations**.
- 2. Members rights and obligations are summarised in the table below:

- COSA Members will be invited to join COSA Groups; however membership of COSA Groups will not be mandatory. It will be explicit that Group membership will entail active contribution.
- 4. All COSA professional, tumour specific and Interest Groups will become "COSA Groups" with same rights and obligations.
- 5. An annual review of COSA Group activities and structure will be conducted as a part of good governance and Groups that are in abeyance may be dissolved at the discretion of the Board on the advice of Council.
- 6. Where there is duplication between a COSA Group and an independent professional

organisation, such as CNSA and MOGA, the COSA Group may not be required. In consultation with the relevant parties and on the advice of COSA Council the Board may elect that the professional organisation that is also a COSA Affiliated Organisation takes that role.

#### THE TOM REEVE AWARD FOR OUTSTANDING Contributions to cancer care

#### 2012 Award Announcement

COSA is pleased to announce the 2012 recipient of the Tom Reeve Award for Outstanding Contributions to Cancer Care, Professor David Ball MB BS, FRANZCR.



Professor David Ball graduated in medicine from the University of Adelaide in 1972, became a Fellow of the Royal Australian and New Zealand College of

Radiologists in 1976, and subsequently received the degree of Doctor of Medicine (University of Adelaide) in 2001 for lung cancer research. Prof Ball has devoted nearly his entire professional life to the care of patients with lung cancer and other cancers of the chest. His primary research interests are tumour volume definition and staging of non-small cell lung cancer, and concurrent drug/radiation therapy of inoperable non-small cell lung cancer.

His current appointment as a highly respected Radiation Oncologist is the Deputy Director, Division of Radiation Oncology and Cancer Imaging Chair, Lung Service (Peter MacCallum Cancer Centre, Victoria). As many noted in letters of recommendation for this award Prof Ball's achievements are too numerous to list, however a couple to highlight are:

- The development of novel radiation schedules and approaches for non-small cell lung cancer.
- Collaboration with basic scientists in designing and interpreting preclinical radiation and radiobiology studies.
- Leadership in major International and National bodies including the International Association for the Study of Lung Cancer (IASLC), Tans-Tasman Radiation Oncology Group (TROG), Australasian Lung Cancer Trials Group (ALTG) and the NHMRC Guidelines for Management of Lung Cancer.
- Teaching and mentoring trainees and young Radiation Oncologists with passion, intellectual rigor and a keen sense that the Radiation Oncologist is above all a doctor whose focus is the patient, not merely a technician focused on the technology.

COSA encourages those attending the COSA-IPOS Annual Scientific Meeting to register for the conference dinner where Professor Ball will deliver his oration and be presented with the Gold Marryalyan.

## **GROUP REPORTS**

## Cancer Nurses Society of Australia

It's been another busy couple of months for the CNSA. Our Winter Congress in July in Hobart lived up to its promise of being a very successful event with an impressive and packed program. This year's theme "Promoting Partnerships for Optimal Patient **Outcomes**" spoke to the potential of nursing to drive innovation and change in the way we engage with people affected by cancer. The conference provided nurses from across Australia with opportunities to explore how we work with each other and, crucially, with other members of the health care team in acute, sub-acute and community settings to drive an agenda of self-management, rehabilitation and survivorship for cancer as it becomes increasingly recognised as a chronic disease. Following the decision at last year's AGM in Sydney to bring about fundamental changes to the CNSA with the introduction of CNSA only membership replacing joint COSA/CNSA membership, I have been working with the COSA Executive and COSA Council on behalf of the CNSA, to ensure that the relationship between CNSA and COSA remains a strong and collaborative one. Details are still being finalised with both Societies confident of a beneficial outcome.

Work is also being undertaken to develop a new CNSA website, ensuring that it becomes a dynamic and relevant communication mechanism for all CNSA members. Several of the NEC and national CNSA members have been working incredibly hard with our website designers, and our "new look" website was presented to members for their review and feedback at Winter Congress in Hobart.

With the "new look" website comes an opportunity to consider whether CNSA needs to refresh our logo. At

Winter Congress, a series of new logos were presented alongside our existing logo, for members' consideration.

The last couple of months have also seen the first opportunity to celebrate our new relationship with the New Zealand Nurses Organization (NZNO) – Cancer Nurses Section. On 2-3 May, I was fortunate to have the opportunity to attend and present at the NZNO Cancer Nurses Section meeting in Wellington. It was an enthusiastic meeting of dynamic NZ nurses working to advance cancer care across the country. Many of the issues we discussed are similar across Australia and NZ and there is clearly great opportunity for both Organizations to work together to drive improvements in outcomes for people affected by cancer.

As always, the Regional Groups, the Specialist Interest Groups and individual members have been very active on behalf of the CNSA and the energy they so generously put into the CNSA is recognised far beyond the shores of Australia. This year, in Prague, the CNSA will for the first time have a presence in the form of a booth at the International Society of Nurses in Cancer Care Conference in September. The CNSA already enjoys a long and strong association with the ISNCC but this will be the first time that the CNSA will have a visible presence, where nurses from around the world can visit the CNSA booth and find out more about our dynamic Society. While in Prague I will also be exploring opportunities to link CNSA members with members of the European Oncology Nursing Society.

In May, Vivienne Van Dissel joined as the new ACT Representative to the CNSA NEC, replacing Megan Nutt who has now moved fully into the CNSA Treasurer role. We extend a warm welcome to Vivienne and look forward to engaging her in the work of the CNSA and COSA.

The COSA meeting itself will highlight Melanoma on the Wednesday and Thursday and there is an extremely interesting program particularly around the new targeted therapies.

I also wish to recommend to you an excellent article from the United States of America which is a clinical practice guideline for Sentinel Node Biopsy in Melanoma developed by ASCO and SSO, a link is attached below. This gives an excellent summary of the state of play of Sentinel Node Biopsy.

Two other single-day meetings are also scheduled alongside the main familial cancer meeting; one is focussed on cancer risk prediction http://www.pedigree.org.au and the other on the effect of mammographic density on breast cancer risk http://www.sph.unimelb.edu.au/ystudymd. Both of these meetings are very complementary to the main familial cancer meeting so would be worth considering for anyone intending to travel up to Kingscliff for the main meeting.

Next year the familial cancer Clinical Professional Day will take place alongside the COSA ASM in Adelaide as the Familial aspects of cancer: research and practice 2013 meeting is already a large meeting combining with the InSIGHT consortium.

The COSA FCC Group has been preparing a position statement for COSA about the marketing of the Brevagen breast cancer risk genetic test that is available for ordering by any doctor, not just those who specialise in familial cancer. The statement is in its final stages and will be signed by COSA, Human genetics Society of Australia (HGSA) and the Royal Australian College of Pathologists. The statement covers the clinical utility and discriminatory ability of the test and highlights the fact that this is still a genetic test and as such would need to be declared to an insurance company when applying for new insurance policies. The statement suggests that use of this test is still best considered as part of a specialised assessment through a familial cancer genetics service/by a medical professional experienced cancer risk assessment.



Since I started as the Chair of the Familial Cancer Group I have sent out a monthly update to the Group about potentially interesting findings/events pertaining to the practice of familial cancer. These are sent out in email format. Anyone interested in receiving these email updates is very welcome to join the COSA FCC Group by contacting Fran Doughton at COSA, email cosa@cancer.org.au. In recent times I have highlighted the recent grating of an MBS listing for a germline genetic test, VHL, and how this might be the start of a new funding mechanism for genetic testing. Whether the MBS route is the most attractive for funding genetic tests given the rapidity of change in technology and knowledge in this area is still under debate and views of the clinical and laboratory community are being sought. It is important that the funding mechanism is got right as we know the demand for genetic testing will only continue to increase. The recent article showing a high rate of germline BRCA mutations in serious ovarian cancer and the presence of a BRCA mutation has an important impact on survival and response to systemic chemotherapy is just one example of how germline genetic testing will soon be part of routine clinical oncology practice.

The FCC Group is also looking at ways of increasing membership both of COSA and the FCC Group. There is a large group of people who work in familial cancer but are not members of COSA or have ever considered joining COSA. Many of these are genetics-focussed and cancer genetics many only play a partial role in their day to day practice. The FCC Group is working with the HGSA to engage the genetic counsellors and laboratory scientists who would like access to a Group for professional engagement and to help drive development of this speciality for the benefit of our patients and delivery of our professional services.

## **Medical Oncology Group of** Australia

Life at MOGA is never dull and includes participating in an array of meetings including the recent June Scientific Meeting of the American Society of Clinical Oncology (ASCO) in Chicago. It was good to catch up with our colleagues in the US and from around the world. Best of ASCO® Australia on Saturday August 11 in Brisbane will provide a fantastic opportunity for all Australian oncology professionals and allied health professional members to review and debate the ASCO highlights, consider new developments since June and review these in the light of the Australian context with local and international tumour specialists.

During ASCO I had a profitable meeting with the European Society for Medical Oncology (ESMO) including President Professor Martine Piccart. ESMO is a valued collaborator and MOGA is currently working with ESMO and other collegiate organisations in America, Europe, Asia and Africa to encourage more interchange including fellowships, awards, trainee exchanges,

scientific meetings and other mutually beneficial educational and professional development opportunities. I have also recently been appointed as the ESMO Australian and Pacific Regional representative. In this new capacity it is noteworthy that the Australia and Asia Pacific Oncology Research Development Workshop 2012 (Coolum, Sunshine Coast Queensland, 9-14 September) is fast approaching and under the leadership of A/Prof Martin Stockler will include a new complement of leading international cancer specialists as faculty and a dynamic new learning program providing craft specific clinical trials training sessions. Congratulations go to the MOGA Secretariat for securing additional funds not only for ACORD from a range of new sources but most notably a major new travel award for Australian medical oncologists to study abroad valued at \$10,000, supported by the Astellas Oceania Foundation.

The MOGA Executive members have kept busy over the last months and we thank them for their efforts. We welcomed Dr Joanna Dewar, to the Executive to represent the West. Dr Rosemary Harrup is to be congratulated for taking on the role of Deputy Chair and has also been active in working with the Australian Health Workforce Agency on workforce issues on MOGA's behalf, including a recent submission on workforce vulnerabilities. MOGA also recently made a submission to the Strategic Review of Health and Medical Research (The McKeon Review). The Review provides a long overdue opportunity to identify how Australia can continue to grow and develop our health and medical research sector both nationally and globally, culminating in the development of a 10year strategic health and medical research plan for the nation to be released in September. The Review is also an opportunity to examine and re-focus our national health and medical research priorities to ensure that they are better integrated with the economic, social and environmental challenges and opportunities for the sustainable development of our nation. MOGAs submission aimed to ensure that Australia's national health and medical research effort incorporates the full range of mechanisms to support the conduct of oncology health and medical research at international best practice standards and the findings of that research is incorporated into clinical practice, national healthcare policies and programs. Highlights from our submission are:

- It is estimated that our national health system expenditure will grow to \$3.3 trillion by 2023 and our national health costs are projected to increase from 9.3% in 2003 to 12.4% of GDP in 2033, reflecting the ageing population and increased burden of diseases, such as cancer. MOGA asserts that without matching investment in health and medical research, Australia will not be able to respond optimally to this demand and disease burden.
- MOGA believes that the establishment of a coordinated strategic approach to the funding, planning and implementation of Australian cancer research through a National Cancer Institute is needed to achieve greater efficiencies and ultimately

better national outcomes in cancer control, management, patient care and clinical practice.

MOGA believes that there is a need for increased research on; population health and health services to support prevention, morbidity and mortality initiative; clinical, health services and translational research to ensure best practice supportive care and services, along with innovation and efficient service delivery to cancer patients; survivorship and palliative care in recognition of the unmet needs of people with cancer, end of life and associated care requirements, the needs of carers and family members and the growing number of cancer survivors

Our commitment to oncology education training saw the successful delivery of the fourth Sciences of Oncology Program in May which was attended by fifty-four medical oncology trainees from around the country. Our thanks to all the presenters, as well as Professor Stephen Clarke AOM and the MOGA National Trainee representative Dr Deme Karikios who developed this year's Program with its strong focus on new developments in the sciences of oncology for clinical practice.

The Association's work with oncology drugs, treatment and related issues is a priority. A new MOGA oncology Drugs Working Group including Dr Christopher Steer and A/Professor Michael Michael and representatives of the PCPA and HSANZ is now meeting quarterly with the PCAC, DOHA and other groups. Some of the key issues and activities in this area include;

Authority Streamlining

Parity in streamlining in public and private sectors is an important step in advancing e-prescribing.

Recent Oncology Drug Submissions: Prostate Cancer Drugs and Metastatic RCC

MOGA has made two recent oncology drugs submissions to the PBAC. The first on melanoma drugs (vemurafenib and ipilumumab) and the cobas 48000braf v600 mutation test plus the vexed codependent technology process. The second submission was to support the application to the PBAC for reimbursement for neoadjuvant trastuzumab for early and locally advanced breast cancer.

National Drugs Shortages

The issue of drug shortages had come to prominence in Australia over the last 6-12 months. There are many reasons behind the shortages most related to manufacturing. MOGA, the COSA Pharmacy Group and related stakeholder groups have written to Government advising that Australia needs to follow the US model, including implementation of rules that require companies to alert Government and the TGA of any impending shortages; make this information available on a dedicated website; and TGA be able to identify another source for the drug within a set period of time to avert the shortage. Listings for Orphan and Off Patent Oncology Drugs

MOGA is currently in discussions with the regulators on priority drugs that are not listed on the PBS, are off patent, are listed for limited indications, or where listing would result in no cost and consideration, could be given to deregistering them, changing listings or developing ways of allowing them into appropriate clinical use.

MSAC and Co-dependent Technologies

MOGA is concerned that technology is moving so rapidly that a monopoly on testing does not occur, that standards are introduced and that any test approved can be delivered at any laboratory/facility in Australia.

Electronic Prescribing

MOGA has advocated for the need to make e-prescribing available through both the public and private systems and issues surrounding off the chart prescribing in the public sector and additional streamlining across both sectors.

And finally, the scientific program for the 2012 MOGA ASM, 8-10 August, Targeting Cancer from Diagnosis to Cure at the Sofitel Hotel, Brisbane, will focus on targeted therapies and new advances in melanoma, lung, breast, prostate and colorectal cancers. A line up of distinguished local and international guest speakers has been organised; including Professor Heinz-Josef Lenz and Professor Lillian Siu (USA), Professor Alberto Sobrero (Italy) and Professor Ian Tannock (Canada). Leading Australian invited speakers include Professor Grant Macarthur (Melbourne), Professor Michael Boyer (Sydney), Associate Professor Nicole McCarthy (Brisbane) and Dr Ben Tran (Melbourne). Two Industry Symposia will focus on high interest subjects, the first on Surrogate End Points in Oncology Drugs with Dr Suzanne Hill, the new Chair of the PBAC. This is an important opportunity to address a key issue that requires national attention and the input of our profession. The second Industry Symposium with Professor Alberto Sobrero, chaired by A/Prof Nick Pavlakis, on angiogenesis in clinical practice will also be one of the many meeting highlights. We look forward to welcoming our oncology colleagues to the Brisbane meeting which promises to be another robust, dynamic and informative professional development and networking opportunity for consultants, trainees and other allied health professionals.

#### **Clinical trial news**

ANZCHOG and its trials sub-group, Australian Children's Cancer Trials (ACCT) currently have six multi-site trials open to recruitment across Australian and NZ children's cancer centres and are undertaking one preclinical study. Another two multi-site trials are expected to be opened soon.

ANZCHOG/ACCT have continued to build their international collaborations, with ACCT hosting a meeting of the five international early phase paediatric oncology groups in early June alongside the ASCO Chicago meeting. The group has been named the Early Phase Paediatric International Cancer (EPPIC) Alliance, and will assist ACCT to facilitate the conduct of additional early phase trials in Australia and NZ.

#### ANZCHOG Clinical Trial Research Initiatives

ANZCHOG continues to build the capacity for our members to undertake research and clinical trials through a range of initiatives. Recently, ANZCHOG recognised the limited funding available to small research projects and awarded seed funding through a competitive process to three exciting projects that we hope will provide the foundation for larger, externally funded paediatric projects. Later this year, ANZCHOG will be launching a series of trial and concept development workshops to encourage the development of investigator-initiated, national collaborative trials.

#### Member support and development

ANZCHOG has supported our members to undertake a range of professional development opportunities,

including completion of Specialist Certificate in Clinical Research (Oncology), provided support for members to participate in MJA's Clinical Trials Research Summit in Sydney, funding support for members to attend ASM, and have recently offered a joint ANZCHOG/UCLH clinical fellowship in paediatric & adolescent haematology and oncology. In addition, ANZCHOG supports our members to develop their trial development skills through attending workshops hosted by Cancer Research Economics Support Team and Cancer Australia's Chair in Quality of Life.

#### **Psycho-Oncology Awards**

Nominations for the inaugural COSA Psycho-Oncology Awards given in partnership with the COSA, OZPOS and the Psycho-Oncology Cooperative Research Group (PoCoG) have now closed and are under consideration by the awards committee. The first is the COSA Psycho-Oncology Award designed to recognise the highest level of contribution to psycho-oncology. The second is the COSA New Investigator Award recognising a psycho-oncology investigator, early in their career, who has made an outstanding contribution through their research. These awards will be presented during the combined IPOS-COSA meeting this year – an added incentive to come to the meeting and share in the recognition of your colleagues.

#### Fear of Cancer Recurrence – a PoCoG Clinical Research Project

The PoCoG Team are currently recruiting psychooncology health professionals to participate in a randomised controlled trial of an intervention to reduce fear of cancer recurrence after a diagnosis of cancer. After diagnosis and completion of adjuvant therapy up to 50% of people will report clinically significant levels of fear of cancer recurrence (FCR). We lack evidencebased treatments for high FCR.

## **Urologic Oncology Group**

As I come to write this report it gives me the opportunity to reflect on the Group and how it is working. COSA Council has also been thinking quite a bit about how Groups will operate in the future and particularly those like ours with close links to other organisations with similar but incompletely overlapping agendas. In the case of the Urologic Oncology Group our interests and membership overlap with ANZUP Cancer Trials Group and most of the activity in the group since the last report has been under the auspices of ANZUP, as described below.

There do remain however significant points of difference between the groups. ANZUP is a cooperative clinical trials group with the mission to conduct and promote cooperative clinical trials and psychosocial research in prostate and other urogenital cancers, and the vision of conducting such research to improve treatment of these cancers. This includes functions such as involvement of a diverse range of disciplines, building collaborations and shared systems, fostering a culture of research, and providing training opportunities. COSA has additional roles in terms of advocacy, public education, influencing health policy, research links other than clinical trials, and providing broader educational initiatives beyond only genitourinary cancer predominantly in the context of the COSA ASM, where we have the opportunity to mix with and learn from clinicians and researchers in other cancer types. COSA and ANZUP have additional roles in other initiatives such as national tissue banking strategies and in setting up systems such as the recently completed Enabling Grant. For these reasons I continue to encourage all of you with an interest, and particularly younger clinicians and researchers, to join and contribute to both groups.

ANZUP has been very active since the last report, culminating in our highly successful and first standalone Annual Scientific Meeting, held in Sydney on 15-17 July 2012 and convened by Peter Grimison, Paul Sved and Amy Hayden with the wonderful and tireless support of Marg McJannett with the assistance of our project officer Yi Feng. Over 190 delegates attended a feature packed program, including the contribution of our four outstanding international speakers: Daniel Heng, Shahrokh Shariat, Michel Bolla and Donna Berry. Kicking off the first day was our Trainee Day coordinated by Shomik Sengupta and Paul Sved with sponsorship from Abbott and Amgen Oncology. This was based on the highly successful CPD initiative run jointly by ANZUP and the COSA Urologic Oncology Group at the ASM in Perth in 2011. Many thanks to the chairs, panellists and of course the attendees. We plan to make this an annual event.

The first day of the ASM also saw an educational forum for the ANZUP Consumer Advisory Panel, followed by the ANZUP Community Engagement Forum entitled, "A little below the belt." This forum showcased both consumers and clinical leaders and was intended to improve awareness of clinical trials and to facilitate

community involvement. The forum was followed by an open meeting of the ANZUP Scientific Advisory Committee and then the welcome reception. Monday 16 July saw the commencement of the scientific program which began with a Meet the Expert breakfast session on RCC (Danny Heng) and urothelial cancers (Shahrokh Shariat). We were delighted to welcome the Federal Minister for Health, the Honorable Tanya Plibersek MP who officially opened the conference. The plenary session covered bladder, prostate and testicular cancer and was followed by sessions on ANZUP trials and collaborative research updates.

Monday afternoon saw a very vigorous concept development session and was followed by another session dealing with minimizing the adverse effects of therapy. This was followed by the ANZUP AGM and a poster walkaround session, and the much-anticipated conference dinner.

#### ACT & NSW Oncology Weekend (ACTNOW) 2012

Following on from the success of the 2010 ACTNOW workshop, COSA once again hosted this educational weekend for medical oncologists and advanced trainees in the ACT and NSW region.

ACTNOW 2012 was held at the Gibraltar Hotel in Bowral from the 18-20 May 2012.

This unique meeting focuses on a broad range of topics within medical oncology as well as key aspects of patient care across the spectrum of cancer care and general medicine. In attendance was a mix of 50 medical oncologists and advanced trainees, many of which took advantage of the beautiful surrounds and had their families join them for the weekend. Delegates learned about new advances in genitourinary cancers and the new agents in kidney, bladder and prostate malignancies as well as non-ovarian gynaecological cancers. ## **COSA Interest Group Updates**

## **AYA Interest Group**

COSA is still continuing to implement three of the Youth Cancer Networks Program (YCNP) national projects, intended to improve management and care of adolescents and young adults (AYAs) with cancer by:

- 1. Developing an AYA Cancer Network
- 2. Producing AYA cancer clinical practice guidance and protocols
- 3. Increasing AYA cancer clinical research and participation of AYAs with cancer in clinical trials

These projects were funded by the Australian Government's YCNP, administered by CanTeen.

#### AYA Cancer Network

Information was disseminated to the AYA Cancer Network members about resources and education opportunities, such as:

- Collaboration opportunity on NHMRC-funded research project "Patterns and Experiences of Care for Adolescents and Young Adults with Cancer"
- OnTrac@PeterMac AYA oncology seminar, Melbourne
- CanTeen skills based group support program "Truce"
- NCI Cancer Bulletin feature article on AYA cancer survivors and chronic health problems

COSA has also received funding to conduct a sixth AYA Cancer Workshop in 2012. Planning for this workshop has now commenced, with current activities centred

on program development and speaker confirmation. The workshop is expected to be held on **Monday 12 November 2012** in Brisbane, prior to the Annual Scientific Meeting (13-15 November). Further details will be available soon.

#### Clinical practice guidance and protocols

COSA, with the invaluable assistance of expert working groups, has been developing clinical practice guidance about three areas of AYA cancer management:

*Fertility preservation:* This guidance on fertility preservation for AYAs diagnosed with cancer includes advice about discussing fertility risks and options with young people, assessing risk, fertility preservation options, and monitoring for late effects on reproductive function and endocrine and sexual health. The guidance is complete and available on COSA's wiki site at: http:// wiki.cancer.org.au/australia/COSA:AYA\_cancer\_fertility\_ preservation. COSA has begun to promote the guidance to health professionals and relevant organisations across Australia.

*Psychosocial management:* This guidance provides 'good practice points' to assist health professionals in recognising and meeting the particular psychosocial needs of their AYA patients. The guidance is now complete and available on COSA's wiki site at: http:// wiki.cancer.org.au/australia/COSA:Psychosocial\_ management\_of\_AYA\_cancer\_patients.

COSA has begun to promote the guidance to health professionals and relevant organisations across Australia.

*Early Detection:* This guidance is intended to help general practitioners and other primary health care professionals with early detection and appropriate referral of AYAs with suspected cancer. The draft guidance has been completed and loaded onto COSA's Wiki site at: http://wiki.cancer.org.au/australia/ COSA:Early\_detection\_of\_cancer\_in\_AYAs

Following final review by the Department of Health and Ageing, COSA will promote the guidance to health professionals and relevant organisations across Australia.

As part of this YCNP project, Cancer Institute NSW (CINSW) has also developed a range of point of care evidence-based protocols/resources. These are published on the eviQ website (www.eviq.org.au) under the AYA content stream. Information includes links to relevant AYA resources, eviQ AYA frequently asked questions, fact sheets, patient information sheets and treatment statements.

## Supporting clinical research and increasing trials participation

The purpose of this project is to encourage and support development of new clinical research that addresses an identified priority cancer type or issue for AYA patients – where there is a reasonable cohort of AYA patients and/ or a significant survival gap.

Recruitment for the AYA-PK Study is on-going at several centres in Australia. This study investigates pharmacological and pharmacodynamic activity of chemotherapy in patients with Ewing sarcoma, osteosarcoma and Hodgkin's lymphoma and how it varies as an effect of puberty and gender.

The ALL6 trial – investigating whether a paediatric acute lymphoblastic leukaemia (ALL) treatment protocol can be extended to patients aged 15-40 years in adult settings and examining factors that might impair dose delivery – is open for recruitment and sites have been activated across Australia.

## New fertility decision aid is now available



Fertility-related Choices: A Decision Aid for Younger Women with Early Breast Cancer is a free booklet for young women

who have recently been diagnosed with early breast cancer.

This booklet can assist health professionals in starting the difficult conversations with women about breast cancer treatment, how it can affect fertility, and fertility options to consider. There are also some worksheets to help women think about these issues.

This booklet may be helpful to women who:

- have recently been diagnosed with early breast cancer
- are still of reproductive age (having regular periods and no menopausal symptoms), and
- are thinking of starting a family or having more children in the future.

"I wish this resource had been available when I was diagnosed. I spent hours googling and trawling through internet sites looking for the very information in the Fertility Choices decision aid. No one can tell you what impact your treatment will have on your fertility, it is important that young women go into their fight armed with this valuable information to make informed decisions". - Genva

The booklet was developed by University of Sydney PhD candidate Michelle Peate, with the guidance of a reference group of leading Australian breast cancer experts. The production and distribution of the booklet is a collaborative effort between the McGrath Foundation and Breast Cancer Network Australia.

## **Biobanking Interest Group**

In late 2009 the Centre for Genetic Epidemiology & Biostatistics at the University of Western Australia (UWA) developed an open-source platform to provide a suite of secure, integrated web-based tools that incorporate the functions required to conduct a complex study or clinical trial. In 2012 COSA became part of The Cloud-based Bioinformatics Tools project based on this platform, funded by the Australian government's National eResearch Collaboration Tools and Resources (NeCTAR) initiative. This project is a collaboration between the Centre at UWA, The Centre for Mega Epidemiology at Melbourne University, St John of God Hospital, Perth and COSA. The Cloudbased Bioinformatics Tool will be developed to include additional functionality required by cancer clinical trials for data collection, tissue banking and analysis. Pilot projects have been identified and will be tested over the next few months in collaboration with the NHMRC Clinical Trial Centre.

## **Cancer Care Coordination Interest Group**

In the last edition of the Marryalyan, we reported on the 2012 National Cancer Care Coordination Conference, Towards New Horizons, held on 6 –7 March 2012. The conference was attended by 257 participants from across Australia and New Zealand. There were many excellent presentations addressing interesting new developments in cancer care coordination. I encourage you to review the site for more information.

Since the conference, the Cancer Care Coordination Interest Group has spent some time reviewing issues identified in this final 'open forum' discussion session held at the end of the conference. The open forum provided an opportunity to review achievements of the group to date, and discuss priorities for the future in three key areas, research, education and collaboration. Key issues raised by participants during the session related to the continued need to demonstrate outcomes from care coordinator positions, the need to improve access to the coordinators and ensure more standardised approaches to practice to reduce variations across services, and the need for better information and tools to support care coordinator practice. Members also discussed the format and frequency for future Cancer Care Coordination Conferences. The Cancer Care Coordination Interest Group's three working groups have also sought feedback from members about priority issues relevant to cancer care coordination. The Group's executive has collated this information to inform development of a work plan for the next few years. The Executive will meet in August to formulate this plan and we encourage you to email suggestions to committee members.

## **Complementary and Integrative Therapies Interest Group**

The group continues to work on two projects regarding the use of complementary and integrative therapies (CITs) in cancer care. Following discussion at the last COSA Council meeting the CIT Interest Group will form a working party to develop a position statement on the use of complementary and alternative therapies by cancer patients. It is hoped a position statement will provide some guidance for health professionals when a patient choses to use non-advised complementary or alternative therapies.

The CIT Interest Group is also developing a survey to gauge the level of research activity into the application of complementary and integrative therapies in oncology settings around Australia. The aim of this survey is to identify areas of need in this type of cancer research. The survey will inform COSA and interested researchers and practitioners, as well as the policies and priorities of funding bodies, and in turn help ensure Australian researchers and their institutions are included in future funding opportunities.

## **Developing Nations Interest** Group

In 2011 the Developing Nations Interest Group piloted a mentoring program which saw two health professionals undertake fellowships in Australia. Due to the program's success COSA has provided funding to support a fellow in 2012. The mentoring program is aimed at supporting mid-career health professionals from the Asia Pacific region by providing funding for them to spend up to three months at a cancer unit within the Australian hospital system. In 2012 submissions were received from two host institutions and six potential fellows. This year COSA will fund one fellow under this program and will look to apply for AUSAid funding for a second.

The Review Committee assessed the applications and met via teleconference to discuss the candidates for the funding. The Committee was impressed by the standard of applications received. The process identified some excellent projects in need of a mentor and would greatly benefit from linking with an Australian institution. These included projects in pharmacy, nursing, radiation oncology, and physiotherapy.

In 2012 COSA will fund Dr Sanjay Dhiraaj, a Professor within the Department of Anaesthesiology at Sanjay Gandhi Post Graduate Institute of Medical Science (SGPGIMS) from India. Sanjay will be arriving in Australia on a 10-12 week term in either September or October, with the exact date of be confirmed. He will be mentored by Dr Odette Spruyt, Director of Pain and Palliative Care at the Peter MacCallum Cancer Centre. COSA wishes to thank Odette and her team who have kindly provided their time to support the Fellowship program.

Whilst based at the Peter MacCallum Cancer Centre, Sanjay will experience the care of cancer patients in a comprehensive, multidisciplinary team. This will include having the opportunity to observe how patients are managed in the hospital and community from diagnosis through to end of life care. Sanjay wishes to use these observations and programs to aid the formulation of palliative care protocols at SGPGIMS. Part of his training will see him develop his communication skills in a methodological fashion as an essential element in providing palliative care. Sanjay's placement will provide a valuable, ongoing relationship with Peter MacCallum Cancer Centre. He aims to develop a training program in his home Institution which will hopefully see correspondence maintained with Odette through knowledge sharing and the evaluation of his project's at SGPGIMS.

Sanjay will attend the COSA ASM in November and have the opportunity to connect and engage with health professionals from all cancer areas. I encourage you to listen out for any information regarding the Developing Nations Interest Group at the COSA ASM and introduce yourself to Sanjay.

The Developing Nations Interest Group will apply for AUSAid funding in October 2012. In the hope of obtaining a grant, this would allow COSA to support another fellow under the Asia-Pacific Mentoring Program.

I look forward to welcoming our fellows to our shores later this year.

## Geriatric Oncology Interest Group

The Geriatric Oncology Group is in full swing preparing for some key events in 2013.

The COSA 2013 Annual Scientific Meeting (ASM) will have a focus on Geriatric Oncology throughout the program. Nimit Singhal, a member of our Geriatric Oncology Interest group, and I will be involved in COSA's preparations leading up to the 2013 ASM. Nimit is the convenor for this meeting to be held in Adelaide, and I will be liaising with the International Society of Geriatric Oncology (SIOG) on behalf of COSA to confirm their presence. As a Board member of SIOG I would like to explore how the International Society can increase their link with Australia. With Nimit and myself actively working with COSA I am confident that we can assume a strong Geriatric Oncology presence for this meeting. At around the same time, the November 2013 edition of Cancer Forum will feature Geriatric Oncology. The Group is currently developing a content structure and approaching authors for this edition which will aim to cover current and emerging research, multidisciplinary teams in Geriatric Oncology and perhaps a look at the work of international teams. There will be a great Geriatric Oncology focus in November 2013 in Cancer Forum and at the ASM, and the Group is looking to really capitalise on this and make some strong collaborative connections along the way.

Before the events in November 2013, the Interest Group will hold a Concept Development Day in March. Planning is now progressing well after an initial slow start. This project is being driven by Jane Phillips, Chair of the

Research Working Group with much input from the Executive team. The Concept Development Day will aim to provide a confidential forum for which research proposals can be displayed and discussed. Participants will have the opportunity to present their proposals to the group followed by a facilitated discussion in which to gain feedback on their project. A broad scope of attendees will provide a comprehensive and realistic guideline for the practicality of the proposal. Interested health professionals will be invited to submit an expression of interest and abstract of their research proposal to Kate Whittaker, COSA Project Coordinator. Information for applicants including criteria for submissions and the review process will be made available via the COSA Geriatric Oncology Interest Group member's area of the website in the near future.

Timelines for this process are still being determined with an estimate that expressions of interest will open in October or November this year. Numbers for this day will be limited and a competitive review process will determine final attendance. ## **NETs Interest Group**

The Neuroendocrine Tumours (NETs) Interest Group continues to work on two important projects, the SIGNETURe Registry and the guidelines for the diagnosis and management of gastroenteropancreatic neuroendocrine tumours.

SIGNETURe is an observational registry that facilitates the collection of retrospective and prospective data on patients with NETs in Australia. The number of sites participating in the registry is growing with ethics approval granted for Queen Elizabeth Hospital (SA), Royal Adelaide Hospital (SA) and The Canberra Hospital (ACT) and ethics applications underway at eight additional sites. COSA hopes that the register will facilitate greater understanding of the diagnosis and treatment of NETs in Australia, as well as allowing for the evaluation of long term outcomes to optimise clinical care for patients with these rare tumours.

The guidelines for the diagnosis and management of gastroenteropancreatic neuroendocrine tumours (GEP-NETS) were developed through a collaborative effort between clinicians from Australia and New Zealand in 2009. They have been hosted on the COSA website since they were launched on the wiki platform in 2010 and have served as national guidelines for Australia, with regular updates made by the group to reflect emerging treatment advances. The guidelines will be adopted as national guidelines in New Zealand in August 2012, and will serve to strengthen cooperation on both sides of the Tasman to progress the management of this rare group of diseases.
