Background

The Clinical Oncology Society of Australia (COSA) is the peak national body representing health professionals from all disciplines whose work involves the care of cancer patients.

Vision: Quality multidisciplinary cancer care for all.

Mission: To improve cancer care and control through collaboration.

Telehealth is the use of telecommunication techniques to exchange health information and provide health care and health education over a distance.

Telehealth services use information and communications technologies to transmit voice, data, images and information rather than moving patients, health professionals or educators.

Telehealth encompasses diagnosis, treatment, preventive and curative aspects of healthcare services and typically involves patients and health professionals or educators.

In the cancer care setting telehealth is referred to as teleoncology.
