#### Introduction

The website with the URL <u>www.cosa.org.au</u> is owned and operated by the Clinical Oncology Society of Australia Ltd (COSA).

This Website Terms and Conditions of Use Policy, together with COSA's Privacy Policy are important as they govern your use of our website.

By using the COSA website, you agree to be bound by this policy.

#### Purpose

These Terms and Conditions establish COSA's expectations and requirements for appropriate conduct by users when contributing to or participating in members' only areas including Noticeboards via COSA's website.

#### Copyright

The COSA website and its contents are subject to copyright. The site material copyright is owned by COSA, or in the case of some material, a third party. The site function copyright is owned by <u>Atlas</u>.

#### Terms of Use

You are granted a non-exclusive, non-assignable and non-transferable licence to use the COSA website only under this policy.

You may view the COSA website and its contents using a web browser and electronically copy and print hard copies of parts of the website solely for personal, non-commercial use. Any other use is strictly prohibited.

## Use of Noticeboards

All content to be posted on the Noticeboards on the COSA website is strictly moderated and approved by COSA prior to their publication. Only content supplied by COSA members that is relevant to the audience will be published.

In making any contribution to or using the website Noticeboards, you agree that you will not seek to transmit content or take actions that are defamatory, unlawful, indecent or otherwise inappropriate.

If COSA has any concerns about the content that is transmitted or otherwise intended to be made available on COSA's website, it may refuse to post that content to COSA's website, or suspend, restrict or terminate your access to all or any part of the COSA's website without giving any reason.

In particular you agree not to use COSA's website to:

- a) transmit any content that is abusive, harassing, obscene, defamatory or is otherwise offensive

For the purposes of moderation there are some exceptions which may be permitted:

- the posting of a work that has been created by the user. For example, an article or excerpt created by a user
- where a user posts a small quote. It would generally not be a breach for a Noticeboard user to post the following: The Sydney Morning Herald reported yesterday that "cancer would be in decline by 2020." It would, however, be a breach of copyright if the user copied a substantial portion of the article
- the promotion of educational events
- to congratulate a COSA member on an award or achievement.
